Skills that were worked on: Built a small survival shelter with minimal tools, where to find the driest and best fire starter kindling

and looked for wildlife tracks

One major emphasis was placed upon energy expenditures verses caloric intake. They also discussed the power of the mind as your best tool and your worst enemy.

The boys did great, they ate well, slept some and enjoyed all. 3-1/2 inches of sleet driving out the Blue Ridge highway on Sunday morning! Total trek: 8-1/2 miles in 24 hours or 17,648 steps.

TO: Upper Hudson Woodlands Recreation Lease Club Presidents RE: Lease and Conservation Easement Violations

You are all aware that New York State owns an extensive and intensive Conservation Easement (CE) on the Upper Hudson Woodlands ATP, LP property where your recreation lease is located. The New York State Department of Environmental Conservation (DEC) is responsible for monitoring this easement. You should also already be aware that they have been actively going onto the property and monitoring many different things covered by the CE including (but not limited to) cabin changes and sizes, garbage dumps, trailers not in compliance with permitting and much more. F&W Forestry Services, Inc. (F&W) as the managers of the property has continued to receive notification of a number of violations from DEC.

Your club lease spells out what needs to be done for everybody (lessee, landowner etc.) to remain in compliance with the CE. Furthermore, your lease also spells out a number of different penalties that can be assessed when there are conditions or situations that are not compliant. Since 2009 when F&W took over management of the UHW property there has not been a history of fines levied or of "heavy handed" management. However, F&W continues to receive notices of violations from the DEC. The vast majority should never have happened. The largest violation (but not the only one) continues to be cabins that have been changed or altered so that they are over the size allowed. When a violation is found and proven to be true there is not disagreement the situation must be rectified. F&W will be forced to start levying the fines allowed by lease if this continues.

F&W and UHW continue to acknowledge that the recreation leasing program and the lessees involved are essential to the ability of the property to operate. Peter Nicholas is the Recreation Manager for the property and I encourage you to consult with him when your members are considering any material changes to their cabins, or with other questions that may come into play with the CE. **Please note:** Not all clubs have had violations and issues, but there have been enough that everybody needs to make this a priority.
