CLUB OPEN HOUSE

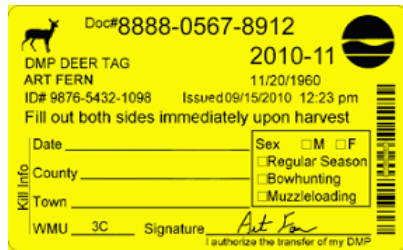

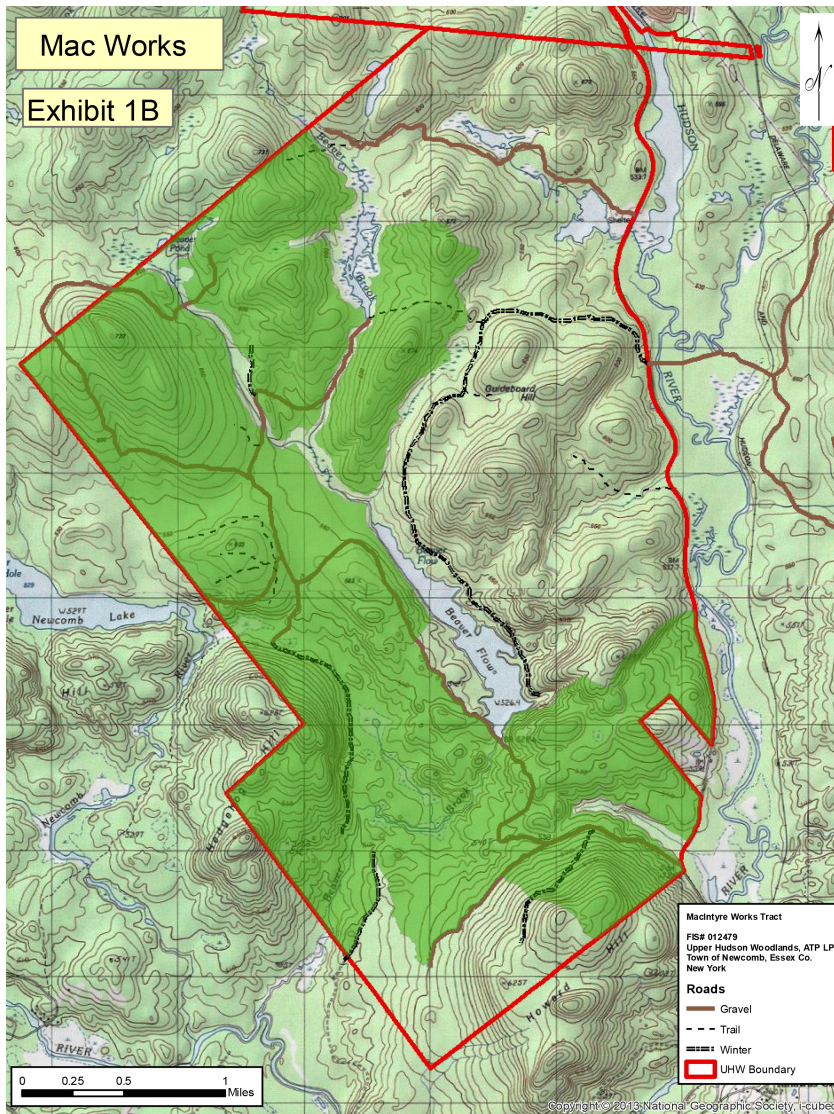

LOGGING UPDATE FROM F&W



F&W loggers have completed the patch clear cuts around the Duck Hole and the shooting range area. **The range area can now be accessed again for sighting in rifles before hunting season begins.** Access to Newcomb Lake through the Duck Hole spur road is open again, although the road was left in poor condition and will be a focus of future Club road work. Loggers are continuing to cut up on Boulder Alley and we have been advised that they will most likely be on the Club through winter.

The dark green on the map indicate areas the loggers have either been or are going to. Jay spoke with the forester recently and he advised that the loggers will be finishing up pieces on Howard Hill this winter and also across the road south of the stream. The loggers will be working out of the large new header on the left before Pine Road. Currently they don't have plans to log Guide board but that may change in coming months.
