- Our membership currently full, with others on a waiting list.
- 5 bucks were harvested this year from the club. None of the allocated doe permits were used.
- **Spring fish stocking** will continue this year as in the past. This will be run by Joe Novak and details will be forthcoming. Moving forward, it is currently being discussed to move bass stocking to every two years, while continuing to stock forage fish on a yearly basis.
- Work days will be: June 22, July 20, and August 1. Work days will be mostly ATV trails, general maintenance of roads and cutting some firewood for the club camp.
- The **club picnic** will be September 14, time and place to be announced.
- **Logging** will continue on Wards Mill road once the roads have dried up, so please use caution and be sure to leave the gate open when they are working.
- The Club had a great turnout for the recent total eclipse on April 8th, with many gathering on the east shore of Wards Mill Pond to view the event. Hundreds more flocked to Overlook Park in the

town of Newcomb and throughout the Adirondacks to see this once in a lifetime show!





Change in land ownership

As of February 1 st this year, property ownership was transferred from Upper Hudson Woodlands to Northway/Eastwood Forests LLC. Lease management was also transferred from F&W to LandVest out of Lowville, NY. We don't anticipate any major changes in the current lease program at this time and will meet with the new owners later in April. The Newcomb Sportsmen's Club, in existence since 1950, will remain strong regardless of the owner.

Dues Billing

The new reduced rate, single billing cycle will continue this year with bills sent out by June 1st and due by August 1st. The invoice will include Club dues (if owed), camp rents (\$500) (\$145.86) if you own a camp, and work day assessments for those who have not fulfilled a workday. If you wish to purchase one, a guest pass (\$50) can also be added to the invoice in addition to big buck club entry (\$10) and fish stocking donations. **Dues payments not received by September 1st may result in loss of membership.** If any member needs special

accommodation for timely payment, please contact treasurer Walt Huba prior to the August 1 st deadline.

BULLET POINTS FOR NEWCOMB SPORTSMEN'S CLUB BY-LAWS

This is a brief summary of the Club's by-laws, and does not replace the complete by-laws.

Locks- locks on gates will be changed around the first week of September

Guest Passes –good for 3 consecutive days or 3 separate days for hunting, fishing, or trapping. people can only be a guest for 2 years

Work Day- members are responsible for 1 work day/year or pay \$100.00

Members in good standing- may vote, hold office, and maintain land rights

Failure to Pay-membership may be forfeited for failure to pay dues within 30 days of billing

Law Compliance- ensure that all federal, state and by-laws are adhered to

Nominations- members may run for office and must submit name to secretary, in writing, by Feb 28

Annual meetings- 2 meetings per year, 1 in May and 1 in November

Violation of Law-liable to \$600/violation

Tree Cutting needs prior approval. Liable to \$250.00 or 3 times value of tree

Unauthorized Roads or Trails- Liable for a fine from F&W

Sale of Camps- must first be approved by board Fishing- conform to NYS laws

Deer- No does except with special permit approved by board

Tree Stands- must be portable and can accommodate no more than 2 people

Feed Plots- prior written approval from F&W

Beaver Flow- no motors except electric motors

Motorized Vehicles - need to be insured and registered with proof sent to secretary. Excludes cars and trucks

Water craft-must display member's membership number

ATV's and UTV's- cannot operate on trails
Oct. 15-Dec. 15 unless it is to retrieve big game. Must
display membership number

Snowmobiles- Can only operate after Northern Big Game season. Must display membership number

Club member's property- anyone caught stealing or damaging personal property will result in expulsion from the club

Club speed limit is 20 mph

NO firewood maybe removed from club property
